## Summary of proceedings of the 15th Annual General Meeting

The 15th Annual General Meeting (AGM) of the Members of D-Link (India) Limited was held on Saturday, September 9, 2023, at 11:00 a.m. IST through Video Conferencing (VC) / Other Audio-Visual Means (OAVM).

In compliance with the provisions of Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and Section 108 of the Companies Act, 2013 and relevant rules made thereunder, the Company had availed e-voting facility from KFin Technologies Limited (KFin) to enable members to exercise their vote for the resolutions stated in Notice of the AGM to be passed through electronic mode. Further, those members who participated in the AGM though VC / OAVM facility were also provided facility of e-voting on KFin/ Insta poll portal during the Meeting.

Mr. Hung-Yi Kao Chaired the meeting. The requisite quorum being present, the Chairman called the meeting to order.

All the Directors attended the AGM. The Chairman introduced the Directors, Company Secretary, Chief Financial Officer of the Company.

The Chairman informed that Mr. Amar Sunder– Partner, M/s B S R & Co LLP and CS Shivaram Bhat, Secretarial Auditor of the Company were also present at the meeting.

The Notice of the meeting was taken as read. The Chairman delivered his speech detailing company's performance and related matters. The members were informed that there were no qualifications or reservation or adverse remarks in the (a) Report of the Statutory Auditor on the Audited Financial Statements of the Company for the financial year ended March 31, 2023; and (b) in the Report of the Secretarial Auditor.

The members were informed that pursuant to the provisions of the Companies Act, 2013, the Rules framed thereunder and the Listing Regulations, the Company had provided the remote e-voting facility to the Members of the Company in respect of the resolutions to be passed at the Meeting. The remote e-voting commenced at 9.00 am on September 6, 2023, and ended at 5.00 pm on September 8, 2023. The facility of e-voting was also made available during the AGM to those Members who did not cast his/her vote earlier through remote e-voting.

The Chairman then thanked the Members for their continued support and for attending and participating in the Meeting through video conference.

The Meeting concluded after the Members present at the AGM casted their votes through e- voting facility.
