Please refer to your email dated 14th December, 2023 at 8:48 P.M., addressed to cs.cfpl@gmail.com in connection with Late filing of Disclosure of Related Party Transactions of the Company for the half-year ended on 30th September, 2023.

Pursuant to Regulation 23(9) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the same was required to be filed simultaneously with the submission of the Un-Audited Financial Results.

For the half-year ended on 30th September, 2023 the Company had duly held its Board Meeting on 9th November, 2023 and the submission of the Un Audited Financial Results were submitted through Online Listing Portal at 6:00:18 P.M.

At that time, unfortunately the XBRL facility on BSE Listing Portal was not working and we tried to submit the Un-Audited Financial Results as well as Related Party Transactions in XBRL format, however the XBRL Portal did not validate and accept the xml file and it was only buffering and could not be uploaded.

Hence, as an abundant precaution, we submitted the Related Party Transactions on the same day by way of Online Submission through Listing Portal at 6:11:19 P.M. The Acknowledgement No. 6434778 generated for the same is attached herewith for your ready information.

Thereafter also, we tried it for several times however, we could not upload in the XBRL Format. We even tried from four other computer systems for submission of the same. Even in the late night, we tried this submission from the residence from my laptop. However, the same could not be uploaded even though we downloaded the new excel file multiple times and tried for the submission.

On the next day morning i.e. on 10th November, 2023 the XBRL facility on Online Portal was working properly and we could submit the Related Party Transactions in XBRL format. The said submission was done on 10th November, 2023 at 01:24:26 P.M.

Thus, the Company has not avoided and delayed on time submission of Related Party Transactions in XBRL Format but the delay was beyond our control. To show our intention to comply with the same on time, we had submitted the same in PDF Format on 'Online Listing Portal' which also is available for the general public for inspection.

The Company is always compliant with the timely compliance and submission of all the compliances under LODR. The delay of few hours occurred was unintentional and beyond our control. We are very much aware of the said compliance under revised Clause 23(9) which was made effective from 1st April, 2023. The Related Party Transactions of the earlier half year ended 31st March, 2023 were submitted to BSE Ltd., in XBRL format on the same day of the publication of Financial Results.

In view of this, you are requested to waive the penalty levied of Rs. 5,000 plus GST of Rs. 900/- and remove the same from the Portal so as to avoid future clearances of our applications, if any.
