## 'Rajasthan govt. has fulfilled promise to waive farm loans'

Congress leader Rahul Gandhi, during his Bharat Jodo Yatra in State, accuses PM Narendra Modi of not fulfilling his promise to give national project status to Eastern Rajasthan Canal Project

Congress leader Rahul Gandhi on Wednesday asserted that his party delivers on its promises and has waived loans of 22 lakh farmers in Rajasthan.

Addressing a gathering during the Bharat Jodo Yatra here, he accused Prime Minister Narendra Modi of

not fulfilling his promise to give national project status to the Eastern Rajasthan Canal Project (ERCP).

"We do what we say," Mr. Gandhi said here.

The Congress government in Rajasthan had pledged to waive farmers' loans in the last Assembly elections. The BJP has accused the Congress of failing to fulfil its poll promise. Mr. Gandhi said eight lakh

farmers get electricity free of cost in the State.

Central hindrance

Talking about the ERCP, he said, "The Prime Minister had twice in his speech promised to 13 districts of Rajasthan to give national project status to the ERCP. He had said he will fulfil it soon. He cancelled it," Mr. Gandhi said. "Now when the Rajasthan government

wants to build the project with its funds, the Centre is stopping the project. The State government has kept aside ₹9,500 crore for the project," he said.

The ERCP is an ambitious project of Rajasthan, which was envisaged during the previous BJP government. It is aimed at providing drinking and irrigation water to 13 districts of the State.

## Case based on alarming phrases: Delhi riots accused

Seeking bail in an Unlawful Activities (Prevention) Act (UAPA) case relating to the 2020 Delhi riots, United Against Hate (UAH) founder Khalid Saifi told the Delhi High Court on Wednesday the case is not based on evidence but "frightening and alarming phrases" put forth by the police and insisted he cannot be kept in indefinite incarceration.

The senior counsel appearing for Mr. Saifi argued before a Bench of Justices Siddharth Mridul and Rajnish Bhatnagar that prejudice was being created by the Delhi police against him when not even a prima facie case was made out.

The court was told the whole FIR was set up on the "opinion of two-three men sitting in special cell office". The counsel claimed the 42-year-old has not committed any violence but was himself a "victim of custodial violence".
