Bharat Forge successfully completes acquisition of JS Autocast

Pune, July 1, 2022- Bharat Forge Limited (BSE: 500493, NSE: BHARATFORG), along with its subsidiary, BF Industrial Solutions Limited (together referred to as "Bharat Forge") today announced that it has successfully completed the previously announced acquisition of JS Autocast Foundry India Private Limited ("JS Auto"). The Enterprise Value of the transaction is Rs 489.63 Crores.

This acquisition significantly enhances our capabilities and addressable market segments both domestically and in export markets, especially in niche industrial segments.
