### **Financial Performance Highlights For FY22 vs. FY21.**

- Total Income increase by 10% to 234.01 crores
- EBITDA increase by 37% to Rs. 7.06 crore
- Profit after Tax increase by 4036% to Rs. 2.27 crore.
- Earning Per Share (EPS) increase by 2467% to Rs. 0.77
- The Company is in the process of becoming net external debt free and already reduce debt in Financial year Y22 by more than 13 crores .
- The Board of Directors have recommended a Dividend of Rs.0.10 per fully paid share of Rs 10/- each of the Company and dividend on partly paid shares will be paid @ Rs 0.025 per partly paid share of Rs 2.50 each for the year ended March 31, 2022 subject to necessary approval by the members of the Company in the ensuing Annual General Meeting.
