This is to inform you that ICICI Prudential Mutual Fund (the Fund) under its various schemes holds equity shares of Cholamandalam Financial Holdings Limited (the company), listed on your stock Exchange.

The Fund under its various schemes has carried out net purchase of 3,04,982 shares of the Company on November 14, 2022. As a result, the shareholding of the Fund has increased by 2.04% of the paid-up capital of the company as compared to previous disclosure on January 27, 2021 for 5.07%
