Please note that GMO Emerging Markets Equity Fund, GMO Emerging Markets Fund and MDPIM Emerging Markets Equity Pool (mentioned in the reporting as "Separately Managed Account managed by GMO") had submitted a report on March 14, 2023 that inadvertently only reflected the sale from 5.24% to 4.80% (i.e., a reduction of only 0.44%) and not from 7.13% to 4.80% (i.e., a reduction of 2.33%), and this revised report is therefore being submitted to reflect the reduction in holding from the last reported position of 7.13% on March 16, 2022 to 4.80% on December 5, 2022.

However, no filing pursuant to Regulation 29 (2) of the SEBI (SAST) Regulations, 2011 was made by the Acquirers since the reduction in shareholding from the last reported percentage was less than 2%. On December 5, 2022, the collective shareholding of the relevant Acquirers in the Target Company reduced by more than 2% from the last reported percentage (i.e., by 2.33%). Accordingly, this disclosure is made to reflect the change of shareholding by 2.33% since the last disclosure made by the Acquirers.
