**Sub: Regulation 29(2) of the Securities and Exchange Board of India (Substantial Acquisition of Shares and Takeovers) Regulations, 2011**


We refer to our letter dated August 23, 2019 wherein we had mentioned that as on August 22, 2019, the aggregate holding of the Schemes of HDFC Mutual Fund in "Tamil Nadu Newsprint & Papers Ltd."
