(+) Since Sands Capital Management, LLC last disclosure to the stock exchanges on March 31, 2021, it has from the time period April 1, 2021 to April 1, 2022 acquired and sold certain equity shares in the TC, in tranches over several days. However, please note that over this period, some clients have also terminated or transferred assets away from their arrangement with Sands Capital Management, LLC removing their assets from our management, including equity shares in TC. Accordingly, on April 1, 2022, Sands Capital Management LLC went below the 2% shareholding threshold in the TC (since its last disclosure on March 31, 2021) and held 6,372,376 equity shares and 4.83% of the share and voting right in the TC.
