**Sub: Regulation 29(2) of the Securities and Exchange Board of India (Substantial Acquisition of Shares and Takeovers) Regulations, 2011**

We refer to our letter dated May 15, 2018 wherein we had mentioned that as on May 14, 2018, the aggregate holding of the Schemes of HDFC Mutual Fund in "Tata Chemicals Ltd." ("The Company") was 7.14% of the paid up equity share capital of the Company (Paid up Equity Share Capital being Rs. 2,547,562,780/- comprising 254,756,278 Equity Shares of Rs. 10/- each).

Further, in accordance with the captioned regulation and other applicable laws / regulations, if any, we wish to inform you that there has been a **decrease** in the shareholding of the Company by the Schemes of HDFC Mutual Fund by 2.28% as of February 26, 2020. As on February 26, 2020 the aggregate holding of the Schemes of HDFC Mutual Fund in the Company is 4.86% of the paid up equity share capital of the Company (Paid up Equity Share Capital being Rs. 2,547,562,780/- comprising 254,756,278 Equity Shares of Rs. 10/- each).
