

Out of the Non-Disposal Undertaking ("NDU") created by Zuari Industries Limited (Formerly Zuari Global Limited) on the 1,25,00,000 equity shares of Chambal Fertilisers and Chemicals Limited, NDU in respect of 6,00,000 equity shares (hereinafter referred as the "said shares") was released by Vistra ITCL (India) Limited (Debenture Trustee acting on behalf of Asia Pacific Pvt. Credit Opportunities 1 Singapore Pte Ltd) ("Lender"). Simultaneously, the Company created pledge on the said shares in favor of the "Lender".
