Subject: Notice of Offer for Sale (OFS) of 1,96,949 Equity Shares (“Shares”) of Rs. 10 each of Kintech Renewables Limited (Scrip Code: 512329) by Promoters/ Promoter Group namely Mr. Gaurank Singhal and Mr. Aditya Singhal through the Stock Exchange Mechanism (the “OFS Notice”).

Pursuant to Clause 5(b) of the SEBI Circular No. CIR/MRD/DP/18/2012 dated July 18, 2012, as amended by circulars nos. CIR/MRD/DP/04/2013 dated January 25, 2013, CIR/MRD/DP/17/2013 dated May30,2013,CIR/MRD/DP/24/2014 dated August 8, 2014, CIR/MRD/DP/31/2014 dated December 1 2014, CIR/MRD/DP/12/2015 dated June 26, 2015 and CIR/MRD/DP/36/2016 dated February 15, 2016 (“**SEBI OFS Circulars**”) issued by Securities Exchange Board of India (SEBI) pertaining to comprehensive guidelines on offer for sale through stock exchange mechanism, we wish to inform you that **Mr. Gaurank Singhal and Mr. Aditya Singhal**, a part of the promoter group of **Kintech Renewables Limited** (the “**Company**”),**being the selling promoter member** proposes to sell **1,96,949** Equity shares of face value of **Rs. 10** each representing **19.69%** of the share capital of the Company on **Day of OFS** through a sale on the separate window provided by BSE Limited in accordance with (i) SEBI OFS Circular (ii) Notice No. 20120727-26 dated July 27, 2012, Notice No. 20130129-23 dated January 29, 2013, Notice No. 20140902-33 dated September 2,2014, Notice no. 20150122-30 dated January 22, 2015and Notice No. 20150702-28 dated July 2, 2015 issued by BSE Limited(the “**Sale**”).

The information required to be announced under Clause 5(b) of the Circular is set out below in tabular form. Other important information in relation to the Sale is set out below under the heading “Important Information”, and the information included therein forms an integral part of the terms and conditions of the Sale. Brokers and prospective buyers are required to read the information included in this Notice in its entirety along with the SEBI OFS Circulars.

<p>Allocation Methodology</p>	<p>The allocation shall be on the Price Priority Method basis at a multiple clearing prices basis in accordance with the SEBI OFS Circulars.</p> <p>Retail Category</p> <p>Retail Investors mean individual investors who place their bids for the Sale Shares for an aggregate value of not more than Rs. 2,00,000 (Rupees Two Lakh Only) across all Stock Exchanges.</p> <p>10% of the Sale size shall be reserved for Retail Investors subject to the receipt of valid bids (the "Retail Category"). The Stock Exchange will decide the quantity of shares eligible to be considered in the Retail Category, based on the Floor Price (defined below) declared by the Seller. Unsubscribed portion of the shares reserved for Retail Investors shall be allotted to the investors in the Non-Retail Category choosing to carry forward their bids on T+1 day and who have not been allotted shares on T day. However, such investors are required to indicate their willingness to carry forward their bids on T+1day.</p> <p>Retail Investors will have an option to place a bid or bid at the cut-off price. The Cut-off prices is the lowest price at which all</p>

the Sale Shares may be sold and shall be determined based on all valid bids received in the Non-Retail category on T day.

Upon determination of the Cut-off Price, the Sale Shares reserved for the Retail Category shall be allocated to the valid bids by the Retail Investors on price priority method at a multiple clearing prices basis in accordance with the SEBI OFS Circulars. In case of excess demand in the Retail category at the Cut-off price, allocation for the Retail Investors bidding at the cut-off price shall be done on proportionate basis. Likewise, if there is excess demand at a clearing price then subject to Sale Shares being available at such clearing price, the allocation would be done on proportionate basis at such clearing price. Bids by retail investors below the cut-off price shall be rejected.

Non – Retail Category

Non-Retail Investors shall have an option to carry forward their unallocated bids from T day to T+1 day. Non-Retail Investors choosing to carry forward their unallocated bids to T+1 day are required to indicate their willingness to carry forward their bids. Further, such Investors can also revise their bids on T+1 day in accordance with the SEBI OFS Circulars.

Non Retail Category Allocation Methodology

No single bidder other than mutual funds registered with the Securities and Exchange Board of India under the SEBI (Mutual Funds) Regulations, 1996, as amended and insurance companies registered with the Insurance Regulatory and Development Authority under the Insurance Regulatory and Development Authority Act, 1999, as amended shall be allocated more than 25% of the sale shares being offered in the Sale.

A minimum of 25% of the shares in the Sale shall be reserved for mutual funds registered with the Securities and Exchange Board of India under the SEBI (Mutual Funds) Regulations, 1996 and insurance companies registered with the Insurance Regulatory and Development Authority under the Insurance Regulatory and Development Authority Act, 1999, subject to receipt of valid bids/orders at or above the Floor Price and as per allocation methodology.

In the event of any under subscription by mutual funds and insurance companies, the unsubscribed portion shall be available to the other bidders.

In case of excess demand from Non-Retail Investors at a particular clearing price and subject to the reservation to the mutual funds and insurance companies and subject to Sale Shares

	being available for allocation at such clearing price would be carried out on a proportionate basis. The allocation to Non-retail Investors shall be at a price equal to the Cut-off Price or higher as per their bids.

For non-institutional investors and institutional investors who place orders with 100% of the order value deposited upfront, settlement shall take place On T+1 day in accordance with the SEBI OFS Circulars. 2. In the case of institutional investors who place bids without depositing 100% of the order value upfront, settlement shall be as per the existing rules for secondary market transactions (i.e., on T+2 day). 3. For the bids received on T+1 day, from the Retail Category, the settlement shall take place on T+3 day. 4. For the bids received on T+1 day, from the un-allotted non-Retail investors who choose to carry forward their bid on T+1 day with 100% of the order value deposited upfront, the settlement shall take place on T+2 day. 5. Accordingly, no documents have been or will be prepared, registered or submitted for approval as a "prospectus" or an offer document with the Registrar of Companies in India under the Companies Act and/or Securities and Exchange Board of India ("**SEBI**") under the SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2009, as amended ("**SEBI ICDR Regulations**"), or to the Stock Exchanges or any other regulatory or listing authority in India or abroad, and no such document will be circulated or distributed to any person in any jurisdiction, including in India. The Bidders acknowledge and agree that any buy order or bid shall be made solely on the basis of publicly available information and any information available with SEBI, Stock Exchanges, Company's website or any other public domain, together with the information contained in this Notice. The Sale is subject to the further terms set forth in the contract note to be provided to the successful Bidders.
