Report on the Audit of Standalone Annual Financial Results

Opinion

- We have audited the accompanying standalone annual financial results of Dollar Industries Limited (hereinafter referred to as the 'Company') for the year ended March 31, 2021, attached herewith, being submitted by the Company pursuant to the requirement of Regulations 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, ('Listing Regulations').
