Pursuant to and in compliance with the NCLT approved composite Scheme of Amalgamation and Arrangement, involving *inter alia* SORIL Infra Resources Limited and Yaari Digital Integrated Services Limited ("the Target Company"), the Target Company had, on August 22, 2022, issued and allotted its 1,11,16,690 (one crore eleven lacs sixteen thousand six hundred ninety) fully paid-up equity shares of face value Rs 2/- each to the public shareholders of SORIL Infra Resources Limited. 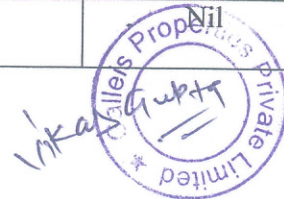

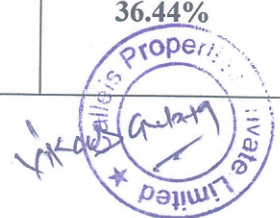
