Few schemes of DSPMF viz, DSP India T.I.G.E.R Fund, DSP Equity Opportunities Fund, DSP ELSS Tax Saver Fund and DSP Small Cap Fund have acquired 20,83,337 shares of the Sansera Engineering Limited ('Company') on 19-June-2024 due to which the shareholding of schemes has increased to 5.78% of the paid-up capital of the Company on account of right issue.


