This is to inform you that ICICI Prudential Mutual Fund (the Fund) under its various schemes holds equity shares of EPL Limited (the company), listed on your stock exchange.

The Fund under its various schemes has carried out net purchase of 11,73,785 shares of the Company on February 03, 2023. As a result, the shareholding of the Fund has increased by 2.31% of the paid-up capital of the company as compared to previous disclosure on December 15, 2022 for 5.05%
