- (#) As the last disclosure made by the seller under Regulation 29(1) of the Takeover Regulations on 19 June 2023, the balance of seller's holding in the TC was 37,37,500 equity shares representing 5.50% of the TC's equity share capital on the relevant day. Subsequently, the total voting shares of the Company was increased from 678,91,497 to 735,56,497 due to further issuance of shares by the Company which reduced the seller's shareholding percentage from 5.505% to 5.081%.
- (##) The seller had net sold an aggregate of 12,24,883 equity shares of the TC in a series of disposals between 16 June 2023 and 11 October 2023. The disclosure obligation under Regulation 29(2) of the Takeover Regulations was triggered pursuant to disposal of 83,059 shares on 11 October 2023, which coupled with previous disposals, crossed the 2% threshold.
