This is with reference to the Notice dated March 6, 2024 filed by us to the BSE Limited (the "BSE") and National Stock Exchange of India Limited (the "NSE", and together with the BSE, the "Stock Exchanges") pursuant to which The President of India, acting through and represented by the Ministry of Coal, Government of India (the "Seller") proposes to sell equity shares of the Company having a face value of ₹10 each representing up to 97,064,562 equity shares, *i.e.*, up to 7.00% of the paid-up equity share capital of the Company (the "Offer Shares") on March 7, 2024 ("T day") (for non-Retail Investors only) and on March 11, 2024 ("T+1 day") (for Retail Investors and for non-Retail Investors who choose to carry forward their un-allotted bids)
