This is to inform you that ICICI Prudential Mutual Fund (the Fund) under its various schemes holds equity shares of Cholamandalam Financial Holdings Limited (the company), listed on your stock Exchange.

The Fund under its scheme has carried out net sale of 17,90,441 shares of the Company on October 17, 2023. As a result, the shareholding of the Fund has decreased by 2.43% of the paid-up capital of the company as compared to previous disclosure on November 16, 2022 for 7.11%.

It may be further noted that the schemes of the Fund have carried out net sale of 45,62,838 shares of the Company from the last filing submitted on November 16, 2022 (for positions held as on November 14, 2022).

The holding by schemes of the Fund are from an investment perspective and not with the objective of seeking any controlling interest.
