12,933,973 Equity Shares will be transferred from Mr. Ashok Kajaria and Mr. Rishi Kajaria in their capacity as the erstwhile joint trustees of the Versha Kajaria Family Private Trust to VK Trustees Private Limited in its capacity as the new trustee of the Versha Kajaria Family Private Trust.

In terms of Regulation 10(1)(a)(iii) of the Takeover Regulations, an acquisition pursuant to a transfer between a company and persons holding not less than 50% of the equity shares carrying voting rights of such company, is exempt from the obligation to make an open offer. In the present case, upon change of trustees of Versha Kajaria Family Private Trust, the equity shares held by Mr. Ashok Kajaria and Mr. Rishi Kajaria in their capacity as trustees of Versha Kajaria Family Private Trust would be transferred to VK Trustees Private Limited in its capacity as a trustee of Versha Kajaria Family Private Trust. Mr. Ashok Kajaria and Mr. Rishi Kajaria in turn control and own 100% of the equity share capital of VK Trustees Private Limited. Therefore, such acquisition by VK Trustees Private Limited would be pursuant to a transfer between a company (i.e. VK Trustees Private Limited) and persons holding not less than 50% (i.e. Mr. Ashok Kajaria and Mr. Rishi Kajaria family Private Trust as contemplated above would have the benefit of the exemption under Regulation 10(1)(a)(iii). Also, there is no change taking place in the aggregate shareholding of the promoter/promoter group of the Target Company.
