We refer to our letter dated October 15, 2020 wherein we had mentioned that as on October 14, 2020, the aggregate holding of the Schemes of HDFC Mutual Fund in "**Transport Corporation of India Ltd.**" ("The Company") was 5.66% of the paid-up equity share capital of the Company (Paid up Equity Share Capital being Rs. 153,992,800/- comprising 76,996,400 Equity Shares of Rs. 2/- each).

Further, in accordance with the captioned regulation and other applicable laws / regulations, if any, we wish to inform you that there has been an **increase** in the shareholding of the Company by the Schemes of HDFC Mutual Fund by **2.04%** as of March 14, 2023.
