Re: Your letter Ref: NSE/LIST/17473 dated April 10, 2019 issued to JSW Steel.

Dear Sir,

We are in receipt of communication from M/s. JSW Steel Limited (JSW Steel), seeking clarification from Virtuous Tradecorp Private Limited (VTPL), a promoter group entity of JSW Steel in response to your above referred letter.

In this regard, we wish to inform you that VTPL had availed a credit facility from L&T Finance Limited (L&T) in March, 2018 and to secure the credit facility, VTPL pledged 33.24 lakh equity shares of JSW Steel and 229 lakh shares of JSW Energy Limited (JSW Energy) in favour of L&T. The requisite disclosures regarding creation of pledge of shares were submitted to the Stock Exchanges and JSW Steel and JSW Energy, respectively, by VTPL under SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011 ("Takeover Regulations") within the prescribed time limit.

Consequent upon repayment of the aforesaid credit facility by VTPL in September, 2018, L&T released 33,15,000 shares of JSW Steel and 2,27,35,500 shares of JSW Energy. However, pending reconciliation of accounts, L&T did not release balance 9,000 shares of JSW Steel and 1,64,500 shares of JSW Energy. Accordingly, the requisite disclosures regarding release of the shares of 33,15,000 shares of JSW Steel and 2,27,35,500 shares of JSW Energy were submitted by VTPL to the Stock Exchanges within the prescribed time limit.

On receipt of your letter, when we checked with L&T, we were surprised to know that it had released its pledge over the balance 9,000 shares of JSW Steel and 1,64,500 shares of JSW Energy on 15th January, 2019 without any intimation to VTPL. Since we did not have any intimation of release of pledge over the balance shares, requisite disclosures for the said shares could not be submitted with the Stock Exchanges.

However, we are now submitting herewith disclosures under Regulation 31 of the Takeover Regulations regarding release of pledge over the balance 9,000 shares of JSW Steel.

We would further like to submit that the delay in filing of the said disclosures was inadvertent and unintentional. You would also appreciate that we have been regular in timely filing of all the disclosures in the past.

In view of the above, we humbly request you to kindly take the above disclosure on record in compliance with the Takeover Regulations.
