Axis Capital Builder Fund – Series 1, Axis Equity Advantage Fund - Series 1, Axis Focused 25 Fund, Axis Growth Opportunities Fund, Axis Midcap Fund and Axis Small Cap Fund are schemes of Axis Mutual Fund and have acquired more than 5% shares of Supreme Industries Limited (Target Company) on September 21, 2020.
