



Rupee rises 15 paise to 82.73, yields soften

AGENCIES New Delhi/Mumbai, February 23

THE RUPEE APPRECIATED by 15 paise to 82.73 against the US dollar on Thursday, tracking its regional peers and lower crude oil prices. Government bond yields ended lower for the first time in three sessions on value buying after the minutes from the Reserve Bank of India's (RBI) latest policy meeting were less hawkish than feared.

Forex traders said a muted trend in domestic equities and foreign fund outflows weighed on the investor sentiment and restricted the appreciation bias in the rupee. During the trading session, the rupee touched a high of 82.71 and a low of 82.79 against the dollar. Yield on the 10-year benchmark 7.26% 2032 bond ended at 7.3905%, after closing at an almost four-month high of 7.4249% on Wednesday.

Reliance Insurance seeks ₹600 cr from parent RCap

RAJESH KURUP Mumbai, February 23

RELIANCE GENERAL INSUR-ANCE Company, a subsidiary of debt-laden Reliance Capital, has sought a capital infusion of ₹600 crore from its parent firm, saying it is continuing to lose business to rivals due to the delay in the holding company's insolvency proceedings.

Reliance General Insurance Company Ltd (RGICL) reiterated its demand for the capital infusion from Reliance Capital(RCap) to improve its solvency level.

The "borderline" insolvency is creating business hesitation among corporate clients, government businesses and creating problems in bagging tenders, key retail and bancassurance partnerships, which is being capitalised by the competitors, according to a financial presentation by the company, which followed its third quarter results.

Hence, the capital support is needed on an urgent basis to preserve the business, enhance its value and take the solvency level from the current 155% to about 175%. This would aid growth of over 20%, which is in line with other companies in the private sector, it said.

The company needs further investment to build up the retail health distribution network, strong digital ecosystem, tech alliances and enter into tie-ups with original equipment manufacturers (OEMs) to capture the fast-growing

electric vehicle segment.

RGICL also highlighted the problem of high attrition levels in the current year, which is impacting client relationships and channel development. The company believes that a fresh fund infusion will not only increase regulatory comfort with the Insurance Regulatory and Development Authority

but also reflect continued support by the promoter company.

This is the second time the company is seeking capital infusion from the parent. In August last year, the RGICL had written to RCap's administrator seeking ₹600 crore capital support by December 31.

For the quarter that ended December 31, RGICL's net earned premium rose to ₹1,599 crore from ₹1,456 crore recorded during the same period a year ago. Its total income rose to ₹1,917 crore from ₹1,756 crore recorded during the corresponding quarter of the last fiscal.

Earlier on November 29, 2021, the Reserve Bank of India superseded RCap's board following payment defaults and governance issues, and appointed Nageswara Rao Y as the administrator for the bankruptcy process. The present deadline to complete the process ends on March 17.

Srei CoC likely to meet next week

MITHUN DASGUPTA Kolkata, February 23

THE CONSOLIDATED COM-MITTEE of creditors (CoC) for two insolvent Srei companies is likely to hold a meeting early next week to discuss the way forward as Authum Investment and Infrastructure, one of the bidders, has challenged the mechanism under which statebacked National Asset Reconstruction Company (NARCL) emerged as the top bidder to acquire the debt-laden companies under the corporate insolvencyresolution process (CIRP).

Authum Investment, whose financial bid was adjudged the second-highest in net present value terms after the challenge mechanism process, has filed a petition before the Kolkata bench of the National Company Law Tribunal (NCLT), challenging the process.

The CoC last week approved the resolution plan of NARCL with the highest voting among the bidders. The resolution plan of the government-owned ARC

was approved with an 89.25% voting share of the CoC for Srei Infrastructure Finance and Srei Equipment Finance. While the resolution plan submitted by Authum Investment received 84.86% vote, that of the consortium of Varde Partners and Arena Investors got 9% vote.

"The approved resolution plan of NARCL was submitted by the administrator to the NCLT on February 18. Meanwhile, Authum has alleged that the evaluation matrix used for selecting NARCL's plan was not

Authum officials were not immediately available for comment. Rajneesh Sharma, the administrator, was also not available for comment.







Rupee rises 15 paise to 82.73, yields soften

AGENCIES New Delhi/Mumbai, February 23

THE RUPEE APPRECIATED by 15 paise to 82.73 against the US dollar on Thursday, tracking its regional peers and lower crude oil prices. Government bond yields ended lower for the first time in three sessions on value buying after the minutes from the Reserve Bank of India's (RBI) latest policy meeting were less hawkish than feared.

Forex traders said a muted trend in domestic equities and foreign fund outflows weighed on the investor sentiment and restricted the appreciation bias in the rupee. During the trading session, the rupee touched a high of 82.71 and a low of 82.79 against the dollar. Yield on the 10-year benchmark 7.26% 2032 bond ended at 7.3905%, after closing at an almost four-month high of 7.4249% on Wednesday.

Reliance Insurance seeks ₹600 cr from parent RCap

RAJESH KURUP Mumbai, February 23

RELIANCE GENERAL INSUR-ANCE Company, a subsidiary of debt-laden Reliance Capital, has sought a capital infusion of ₹600 crore from its parent firm, saying it is continuing to lose business to rivals due to the delay in the holding company's insolvency proceedings.

Reliance General Insurance Company Ltd (RGICL) reiterated its demand for the capital infusion from Reliance Capital(RCap) to improve its solvency level. The "borderline" insolvency

is creating business hesitation among corporate clients, government businesses and creating problems in bagging tenkey retail and bancassurance partnerships, which is being capitalised by the competitors, according to a financial presentation by the company, which followed its third quarter results.

Hence, the capital support is needed on an urgent basis to preserve the business, enhance its value and take the solvency level from the current 155% to about 175%. This would aid growth of over 20%, which is in line with other companies in

the private sector, it said.

RGICL also highlighted the problem of high attrition levels in the current year, which is impacting client relationships and channel development. The company believes that a fresh fund infusion will not only increase regulatory comfort with the Insurance Regulatory and Development Authority

but also reflect continued support by the promoter company. This is the second time the company is seeking capital infusion from the parent. In August last year, the RGICL had written to RCap's administrator seeking ₹600 crore capital support by December 31.

For the quarter that ended December 31, RGICL's net earned premium rose to ₹1,599 crore from ₹1,456 crore recorded during the same period a year ago. Its total income rose to ₹1,917 crore from ₹1,756 crore recorded during the corresponding quarter of the last fiscal.

Earlier on November 29, 2021, the Reserve Bank of India superseded RCap's board following payment defaults and governance issues, and appointed Nageswara Rao Y as the administrator for the bankruptcy process. The present deadline to complete the process ends on March 17.





Rupee rises 15 paise to 82.73, yields soften

AGENCIES New Delhi/Mumbai, February 23

THE RUPEE APPRECIATED by 15 paise to 82.73 against the US dollar on Thursday, tracking its regional peers and lower crude oil prices. Government bond yields ended lower for the first time in three sessions on value buying after the minutes from the Reserve Bank of India's (RBI) latest policy meeting were less hawkish than feared.

Forex traders said a muted trend in domestic equities and foreign fund outflows weighed on the investor sentiment and restricted the appreciation bias in the rupee. During the trading session, the rupee touched a high of 82.71 and a low of 82.79 against the dollar. Yield on the 10-year benchmark 7.26% 2032 bond ended at 7.3905%, after closing at an almost four-month high of 7.4249% on Wednesday.

Reliance Insurance seeks ₹600 cr from parent RCap

RAJESH KURUP Mumbai, February 23

RELIANCE GENERAL INSUR-ANCE Company, a subsidiary of debt-laden Reliance Capital, has sought a capital infusion of ₹600 crore from its parent firm, saying it is continuing to lose business to rivals due to the delay in the holding company's insolvency proceedings.

Reliance General Insurance Company Ltd (RGICL) reiterated its demand for the capital infusion from Reliance Capital(RCap) to improve its solvency level.

The "borderline" insolvency is creating business hesitation among corporate clients, government businesses and creating problems in bagging tenders, key retail and bancassurance partnerships, which is being capitalised by the competitors, according to a financial presentation by the company, which followed its third quarter results.

Hence, the capital support is needed on an urgent basis to preserve the business, enhance its value and take the solvency level from the current 155% to about 175%. This would aid growth of over 20%, which is in line with other companies in

the private sector, it said. The company needs further investment to build up the retail health distribution network, strong digital ecosystem, tech alliances and enter into tie-ups with original equipment manufacturers (OEMs) to capture the fast-growing electric vehicle segment.

RGICL also highlighted the problem of high attrition levels in the current year, which is impacting client relationships and channel development. The company believes that a fresh fund infusion will not only increase regulatory comfort with the Insurance Regulatory and Development Authority

but also reflect continued support by the promoter company. This is the second time the company is seeking capital infusion from the parent. In August last year, the RGICL had written to RCap's administrator seeking ₹600 crore capital support by December 31.

For the quarter that ended December 31, RGICL's net earned premium rose to ₹1,599 crore from ₹1,456 crore recorded during the same period a year ago. Its total income rose to ₹1,917 crore from ₹1,756 crore recorded during the corresponding quarter of the last fiscal.

Earlier on November 29, 2021, the Reserve Bank of India superseded RCap's board following payment defaults and governance issues, and appointed Nageswara Rao Y as the administrator for the bankruptcy process. The present deadline to complete the process ends on March 17.







Rupee rises 15 paise to 82.73, yields soften

THE RUPEE APPRECIATED by 15 paise to 82.73 against the US dollar on Thursday, tracking its regional peers and lower crude oil prices. Government bond yields ended lower for the first time in three sessions on value buying after the minutes from the Reserve Bank of India's (RBI) latest policy meeting were less hawkish than feared.

Forex traders said a muted trend in domestic equities and foreign fund outflows weighed on the investor sentiment and restricted the appreciation bias in the rupee. During the trading session, the rupee touched a high of 82.71 and a low of 82.79 against the dollar. Yield on the 10-year benchmark 7.26% 2032 bond ended at 7.3905%, after closing at an almost four-month high of 7.4249% on Wednesday.

Reliance Insurance seeks ₹600 cr from parent RCap

RAJESH KURUP Mumbai, February 23

RELIANCE GENERAL INSUR-ANCE Company, a subsidiary of debt-laden Reliance Capital, has sought a capital infusion of ₹600 crore from its parent firm, saying it is continuing to lose business to rivals due to the delay in the holding company's insolvency proceedings.

Reliance General Insurance Company Ltd (RGICL) reiterated its demand for the capital infusion from Reliance Capital(RCap) to improve its solvency level. The "borderline" insolvency

is creating business hesitation among corporate clients, government businesses and creating problems in bagging tenkey retail and bancassurance partnerships, which is being capitalised by the competitors, according to a financial presentation by the company, which followed its third quarter results.



HEADWINDS

- Reliance General Insurance Company Ltd sought capital infusion from RCap to improve its solvency level
- The firm said it is losing business to rivals due to the delay in the holding company's insolvency proceedings

Hence, the capital support is needed on an urgent basis to preserve the business, enhance its value and take the solvency level from the current 155% to about 175%. This would aid growth of over 20%, which is in line with other companies in

the private sector, it said. The company needs further investment to build up the retail health distribution network, strong digital ecosystem, tech alliances and enter into tie-ups with original equipment manufacturers (OEMs) to capture the fast-growing electric vehicle segment.

RGICL also highlighted the problem of high attrition levels in the current year, which is impacting client relationships and channel development. The company believes that a fresh fund infusion will not only increase regulatory comfort with the Insurance Regulatory and Development Authority

but also reflect continued support by the promoter company. This is the second time the company is seeking capital infusion from the parent. In August last year, the RGICL had written to RCap's administrator seeking ₹600 crore capital support by December 31.

For the quarter that ended December 31, RGICL's net earned premium rose to ₹1,599 crore from ₹1,456 crore recorded during the same period a year ago. Its total income rose to ₹1,917 crore from ₹1,756 crore recorded during the corresponding quarter of the last fiscal. Earlier on November 29,

2021, the Reserve Bank of India superseded RCap's board following payment defaults and governance issues, and appointed Nageswara Rao Y as the administrator for the bankruptcy process. The present deadline to complete the process ends on March 17.

Srei CoC likely to meet next week

Authum Investment, whose



Reliance Insurance seeks ₹600 cr from parent RCap

RAJESH KURUP Mumbai, February 23

RELIANCE GENERAL INSUR-ANCE Company, a subsidiary of debt-laden Reliance Capital, has sought a capital infusion of ₹600 crore from its parent firm, saying it is continuing to lose business to rivals due to the delay in the holding company's insolvency proceedings.

Reliance General Insurance Company Ltd (RGICL) reiterated its demand for the capital infusion from Reliance Capital(RCap) to improve its solvency level. The "borderline" insolvency

is creating business hesitation among corporate clients, government businesses and creating problems in bagging tenkey retail and bancassurance partnerships, which is being capitalised by the competitors, according to a financial presentation by the company, which followed its third quarter results.



HEADWINDS

- Reliance General Insurance Company Ltd sought capital infusion from RCap to improve its solvency level
- The firm said it is losing business to rivals due to the delay in the holding company's insolvency proceedings

Hence, the capital support is needed on an urgent basis to preserve the business, enhance its value and take the solvency level from the current 155% to about 175%. This would aid growth of over 20%, which is in line with other companies in

the private sector, it said. The company needs further investment to build up the retail health distribution network, strong digital ecosystem, tech alliances and enter into tie-ups with original equipment manufacturers (OEMs) to capture the fast-growing electric vehicle segment.

RGICL also highlighted the problem of high attrition levels in the current year, which is impacting client relationships and channel development. The company believes that a fresh fund infusion will not only increase regulatory comfort with the Insurance Regulatory and Development Authority

but also reflect continued support by the promoter company. This is the second time the company is seeking capital infusion from the parent. In August last year, the RGICL had written to RCap's administrator seeking ₹600 crore capital support by December 31.

For the quarter that ended December 31, RGICL's net earned premium rose to ₹1,599 crore from ₹1,456 crore recorded during the same period a year ago. Its total income rose to ₹1,917 crore from ₹1,756 crore recorded during the corresponding quarter of the last fiscal.

Earlier on November 29, 2021, the Reserve Bank of India superseded RCap's board following payment defaults and governance issues, and appointed Nageswara Rao Y as the administrator for the bankruptcy process. The present deadline to complete the process ends on March 17.





RGICL also highlighted the problem of high attrition levels in the current year, which is impacting client relationships and channel development. The company believes that a fresh fund infusion will not only increase regulatory comfort with the Insurance Regulatory and Development Authority

but also reflect continued support by the promoter company. This is the second time the company is seeking capital infusion from the parent. In August last year, the RGICL had written to RCap's administrator seeking ₹600 crore capital support by December 31.



Rupee rises 15 paise to 82.73, yields soften

AGENCIES New Delhi/Mumbai, February 23

THE RUPEE APPRECIATED by 15 paise to 82.73 against the US dollar on Thursday, tracking its regional peers and lower crude oil prices. Government bond yields ended lower for the first time in three sessions on value buying after the minutes from the Reserve Bank of India's (RBI) latest policy meeting were less hawkish than feared.

Forex traders said a muted trend in domestic equities and foreign fund outflows weighed on the investor sentiment and restricted the appreciation bias in the rupee. During the trading session, the rupee touched a high of 82.71 and a low of 82.79 against the dollar. Yield on the 10-year benchmark 7.26% 2032 bond ended at 7.3905%, after closing at an almost four-month high of 7.4249% on Wednesday.

Reliance Insurance seeks ₹600 cr from parent RCap

RAJESH KURUP Mumbai, February 23

RELIANCE GENERAL INSUR-ANCE Company, a subsidiary of debt-laden Reliance Capital, has sought a capital infusion of ₹600 crore from its parent firm, saying it is continuing to lose business to rivals due to the delay in the holding company's insolvency proceedings.

Reliance General Insurance Company Ltd (RGICL) reiterated its demand for the capital infusion from Reliance Capital(RCap) to improve its solvency level.

The "borderline" insolvency is creating business hesitation among corporate clients, government businesses and creating problems in bagging tenders, key retail and bancassurance partnerships, which is being capitalised by the competitors, according to a financial presentation by the company, which followed its third quarter results.

Hence, the capital support is needed on an urgent basis to preserve the business, enhance its value and take the solvency level from the current 155% to about 175%. This would aid growth of over 20%, which is in line with other companies in

the private sector, it said. The company needs further investment to build up the retail health distribution network, strong digital ecosystem, tech alliances and enter into tie-ups with original equipment manufacturers (OEMs) to capture the fast-growing electric vehicle segment.

RGICL also highlighted the problem of high attrition levels in the current year, which is impacting client relationships and channel development. The company believes that a fresh fund infusion will not only increase regulatory comfort with the Insurance Regulatory and Development Authority

but also reflect continued support by the promoter company. This is the second time the company is seeking capital infusion from the parent. In August last year, the RGICL had written to RCap's administrator seeking ₹600 crore capital support by December 31.

For the quarter that ended December 31, RGICL's net earned premium rose to ₹1,599 crore from ₹1,456 crore recorded during the same period a year ago. Its total income rose to ₹1,917 crore from ₹1,756 crore recorded during the corresponding quarter of the last fiscal.

Earlier on November 29, 2021, the Reserve Bank of India superseded RCap's board following payment defaults and governance issues, and appointed Nageswara Rao Y as the administrator for the bankruptcy process. The present deadline to complete the process ends on March 17.

Srei CoC likely to meet next week

Rupee rises 15 paise to 82.73, yields soften

AGENCIES New Delhi/Mumbai, February 23

THE RUPEE APPRECIATED by 15 paise to 82.73 against the US dollar on Thursday, tracking its regional peers and lower crude oil prices. Reliance Insurance seeks ₹600 cr from parent RCap

RELIANCE GENERAL INSUR-ANCE Company, a subsidiary of debt-laden Reliance Capital, has sought a capital infusion of ₹600 crore from its parent firm, saying it is continuing to lose business to rivals due to the delay in the holding company's insolvency proceedings.

Reliance General Insurance Company Ltd (RGICL) reiterated its demand for the capital infusion from Reliance Capital(RCap) to improve its solvency level.

The "borderline" insolvency is creating business hesitation among corporate clients, government businesses and creating problems in bagging tenders, key retail and bancassurance partnerships, which is being capitalised by the competitors, according to a financial presentation by the company, which followed its third quarter results.

Hence, the capital support is needed on an urgent basis to preserve the business, enhance its value and take the solvency level from the current 155% to about 175%. This would aid growth of over 20%, which is in line with other companies in

the private sector, it said. The company needs further investment to build up the retail health distribution network, strong digital ecosystem, tech alliances and enter into

tie-ups with original equipment manufacturers (OEMs)

to capture the fast-growing

electric vehicle segment. RGICL also highlighted the problem of high attrition levels in the current year, which is impacting client relationships and channel development. The company believes that a fresh fund infusion will not only increase regulatory comfort with the Insurance Regulatory and Development Authority but also reflect continued support by the promoter company.

This is the second time the company is seeking capital infusion from the parent. In August last year, the RGICL had written to RCap's administrator seeking ₹600 crore capital support by December 31.

For the quarter that ended December 31, RGICL's net earned premium rose to ₹1,599 crore from ₹1,456 crore recorded during the same period a year ago. Its total income rose to ₹1,917 crore from ₹1,756 crore recorded during the corresponding quarter of the last fiscal.

Earlier on November 29, 2021, the Reserve Bank of India superseded RCap's board following payment defaults and governance issues, and appointed Nageswara Rao Y as the administrator for the bankruptcy process. The present deadline to complete the process ends on March 17.

Srei CoC likely to meet next week

THE CONSOLIDATED COM-**MITTEE** of creditors (CoC) for two insolvent Srei companies is likely to hold a meeting early nextweek to discuss the way forward as Authum Investment and Infrastructure, one of the bidders, has challenged the mechanism under which statebacked National Asset Reconstruction Company (NARCL) emerged as the top bidder to acquire the debt-laden companies under the corporate insolvencyresolution process (CIRP).



Rupee rises 15 paise to 82.73, yields soften

AGENCIES New Delhi/Mumbai, February 23

THE RUPEE APPRECIATED by 15 paise to 82.73 against the US dollar on Thursday, tracking its regional peers and lower crude oil prices. Government bond yields ended lower for the first time in three sessions on value buying after the minutes from the Reserve Bank of India's (RBI) latest policy meeting were less hawkish than feared.

Forex traders said a muted trend in domestic equities and foreign fund outflows weighed on the investor sentiment and restricted the appreciation bias in the rupee. During the trading session, the rupee touched a high of 82.71 and a low of 82.79 against the dollar. Yield on the 10-year benchmark 7.26% 2032 bond ended at 7.3905%, after closing at an almost four-month high of 7.4249% on Wednesday.

Reliance Insurance seeks ₹600 cr from parent RCap

RAJESH KURUP Mumbai, February 23

RELIANCE GENERAL INSUR-ANCE Company, a subsidiary of debt-laden Reliance Capital, has sought a capital infusion of ₹600 crore from its parent firm, saying it is continuing to lose business to rivals due to the delay in the holding company's insolvency proceedings.

Reliance General Insurance Company Ltd (RGICL) reiterated its demand for the capital infusion from Reliance Capital(RCap) to improve its solvency level.

The "borderline" insolvency is creating business hesitation among corporate clients, government businesses and creating problems in bagging tenders, key retail and bancassurance partnerships, which is being capitalised by the competitors, according to a financial presentation by the company, which followed its third quarter results.

Hence, the capital support is needed on an urgent basis to preserve the business, enhance its value and take the solvency level from the current 155% to about 175%. This would aid growth of over 20%, which is in line with other companies in

the private sector, it said. The company needs further investment to build up the retail health distribution network, strong digital ecosystem, tech alliances and enter into tie-ups with original equipment manufacturers (OEMs) to capture the fast-growing electric vehicle segment.

RGICL also highlighted the problem of high attrition levels in the current year, which is impacting client relationships and channel development. The company believes that a fresh fund infusion will not only increase regulatory comfort with the Insurance Regulatory and Development Authority

but also reflect continued support by the promoter company.

This is the second time the company is seeking capital infusion from the parent. In August last year, the RGICL had written to RCap's administrator seeking ₹600 crore capital support by December 31.

For the quarter that ended December 31, RGICL's net earned premium rose to ₹1,599 crore from ₹1,456 crore recorded during the same period a year ago. Its total income rose to ₹1,917 crore from ₹1,756 crore recorded during the corresponding quarter of the last fiscal. Earlier on November 29,

2021, the Reserve Bank of India superseded RCap's board following payment defaults and governance issues, and appointed Nageswara Rao Y as the administrator for the bankruptcy process. The present deadline to complete the process ends on March 17.

Srei CoC likely to meet next week

MITHUN DASGUPTA Kolkata, February 23

THE CONSOLIDATED COM-**MITTEE** of creditors (CoC) for two insolvent Srei companies is likely to hold a meeting early next week to discuss the way forward as Authum Investment and Infrastructure, one of the bidders, has challenged the mechanism under which statebacked National Asset Reconstruction Company (NARCL) emerged as the top bidder to acquire the debt-laden companies under the corporate insolvency resolution process (CIRP).

Authum Investment, whose financial bid was adjudged the second-highest in net present value terms after the challenge mechanism process, has filed a petition before the Kolkata bench of the National Company Law Tribunal (NCLT), challenging the process.

The CoC last week approved the resolution plan of NARCL with the highest voting among the bidders. The resolution plan of the government-owned ARC

was approved with an 89.25% voting share of the CoC for Srei Infrastructure Finance and Srei Equipment Finance. While the resolution plan submitted by Authum Investment received 84.86% vote, that of the consortium of Varde Partners and

Authum officials were not immediately available for comment. Rajneesh Sharma, the administrator, was also not available for comment.


