This is a reply to the email received on 16.04.2024 from BSE ,I hereby submit my clarifications on the discrepancies observed.

I had pledged 5,00,000 shares of mine for personal borrowings with Organomix Ecosystems Private Limited and the same was previously reported.

On 16.12.2023 the personal borrowings was repaid in full and the shares were released and a release letter of pledge was issued by the Company and the same was reported to BSE and NSE on 22.12.2023. In the disclosure submitted to BSE the transaction date was wrongly mention as 22.12.2023 instead of 16.12.2023, in this re revised disclosure the transaction date has been rectified to 16.12.2023.

The reason for encumbrance is mentioned in the Re- revised disclosure – the personal borrowings on pledge of shares was repaid in full and therefore the pledge was released.

The error in reporting the post even holding after shares encumbered are rectified and reported in the re revised disclosure .

I hereby submit clarifications on the discrepancies observed and request you to kindly accept the same.
