Further to our letter dated November 11, 2016, this is to inform you as on November 10, 2016, the aggregate holding of the Schemes of HDFC Mutual Fund ('the Fund') in "**Apar Industries Limited**" ("the Company") was **8.97**% of the paid up equity share capital of the Company (Rs. 3,84,967,690/- comprising 3,84,96,769 equity shares of Rs. 10/- each).

As a result of the aforesaid transaction the shareholding of the Fund has **decreased** by **0.26%** based on the paid up equity share capital of the Company (Rs. 3,82,686,190/- comprising 3,82,68,619 equity shares of Rs. 10/- each). Therefore, the shareholding of the Fund decreased by 2.19% as compared to the previous disclosure made vide letter dated November 11, 2016.

Accordingly, as on December 07, 2022 the aggregate holding of the Schemes of HDFC Mutual Fund in the Company is **6.78%** of the paid up equity share capital of the Company (Rs. 3,82,686,190/- comprising 3,82,68,619 equity shares of Rs. 10/- each.
