This is to inform you that ICICI Prudential Mutual Fund (the Fund) under its various schemes holds equity shares of PVR INOX Limited (the company), listed on your stock Exchange.

The Fund under its schemes has carried out net acquisition of 1,39,905 shares of the Company on May 15, 2024. As a result, the shareholding of the Fund has increased by 2.10% of the paid-up capital of the company as compared to previous disclosure on April 05, 2024 for 5.01%.
