

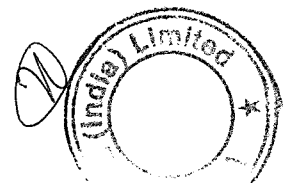



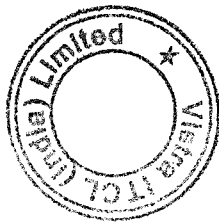
44,52,000 Equity Shares of the Target Company have been sold by Vistra ITCL (India) Limited on the above-mentioned dates.
