1. Allotment of Equity shares:

Allotment of 1,74,165 equity shares of face value of Rs. 10/- each to the Route Mobile Employee Welfare Trust ('ESOP Trust') under RML ESOP 2017. The shares allotted to the ESOP Trust shall be allocated/transferred to the Eligible Employees upon Exercise of Options.

Consequent to this allotment, the paid-up capital of the Company stands increased from Rs. 62,78,85,320 (consisting of 6,27,88,532 equity shares of face value of Rs. 10 each) to Rs. 62,96,26,970 (consisting of 6,29,62,697 equity shares of face value of Rs. 10 each).
