**मायक्रोसॉफ्टची सेवा ठप्प**

**जगभरातील बँक, विमानसेवा, संगणक, लॅपटॉप अचानक बंद पडून माध्यम समूह, कंपन्यांना फटका निळ्या रंगाचा पडदाही दिसू लागला**



**पुण्यातील ट्रक अपघातात ३ ठार, ६ जण जखमी**  
पुणे: पुणे जिल्हाच्या जुन्नर तहसीलमधील आठभट्ट्याजवळ शुक्रवारी एका ट्रकने अनेक जणांना मृत्यू झाला असून अन्य पाच-साह जण जखमी झाले आहेत. अहमदनगर-कल्याण मार्गावर सकाळी ११.३० वाजण्याच्या सुमारास हा अपघात घडला. या अपघातात मरण पावलेले आणि जखमी झालेले शक्यता अंदाजाने आठोपनू परात होते. कल्याणकडे जाणाऱ्या ट्रकचालकाचा उदरगिरावर वाहनचालक तारा सुटल्या आणि त्याने या सर्वाना उडविले. त्यामध्ये एक महिला आणि एका मुलासह तीन जण ठार झाले, तर अन्य पाच-साह जण जखमी झाले. जखमींना जवळच्या रुग्णालयात दाखल करण्यात आले आहे.



**वॉशिंग्टन**: मायक्रोसॉफ्टचा सर्व्हरमध्ये तांत्रिक विघाड झाल्याने जगभरातील चारकरत्यांना शुक्रवारी अनेक अडथळीचा सामना करावा लागला. त्यामुळे जगभरातील विमान कंपनी, दूरचित्रवाहिनी, बँकिंग आणि अनेक कॉर्पोरेट कंपन्यांच्या कामकाजावर परिणाम झाला आहे. अमेरिका, ब्रिटेन आणि भारतासह अनेक देशांमध्ये जवळपास १४०० उड्डाणे रद्द करण्यात आली आणि ३ हजार विमाने उशीराने उडवली. 'मायक्रोसॉफ्ट ३६५'ची सर्विसेस ठप्प होण्यामुळे 'क्राऊड स्ट्राइक'मधील एक अपडेट असल्याचे सांगितले जात आहे. दरम्यान, या विघाडामुळे काही कामे अडथळीत असल्याचे दिसून येत आहे. अनेक बँक, विमानसेवा, संगणक व लॅपटॉप अचानक बंद पडले आणि त्यावर निळ्या रंगाचा पडदा दिसू लागला. यामुळे जगभरातील कंपन्यांनी कामे खोळंबवली. भारतात ईडिओ, स्पॉटसॅट, आकासा एअर, विस्तार आणि एअर इंडिया एक्स्प्रेस या ५ एअरलायन्सनी या **► समिश्त्र पानावर**

क्राऊड स्ट्राइकने यश्र्दनात निवेदन जारी केले आहे. आम्ही या तक्रारीची माहिती घेत असून जवळील पुढील रचना घेत नाही, तोर्यंत युरांनी वाट बघावी. असे त्यांनी या निवेदानात म्हटले आहे. यश्र्दनावर विडोवनर चालणाऱ्या संगणकांमध्ये यश्र्दनासाठी समस्या निर्माण झाली असून युरांनी यश्र्दना या समस्येचे निराकरण करण्याचा प्रयत्न करू नये, अशी सूचनाही त्यांनी केली आहे.

**शिक्षण हक्क कायद्यातील दुरुस्ती घटनाबाह्य**

**उच्च न्यायालयाचा राज्य सरकारला दणका**

**मुंबई**: आरटीई कायद्यात दुरुस्ती करून खासगी शाळांवर मेहनत करणाऱ्या राज्य सरकारला उच्च न्यायालयाने मोठा झटका दिला. मुख्य न्यायाधीश देवेन्द्र कुमार उपाध्याय आणि न्यायमूर्ती अमित कोरकर यांचा खंडपीठाने शिक्षण हक्क कायद्यातील दुरुस्ती आणि वॉचिंग घटकातील विद्यार्थ्यांसाठी राखीव असलेल्या २५ टक्के जागांवरील प्रवेश प्रक्रियेवरून खासगी विनाअनुदानित शाळा यश्र्दनाच्या राज्य सरकारचा निर्णय बेकायदा आणि घटनाबाह्य असल्याचा निर्वाळा देत रद्द केला. विनाअनुदानित शाळांनाही शिक्षण हक्क कायद्यात (आरटीई) राखीव आणि वॉचिंग घटकातील विद्यार्थ्यांसाठी आरक्षण असलेल्या २५ टक्के जागांवरील प्रवेश घ्यावे लागतील, असे उच्च न्यायालयाने स्पष्ट केले. मात्र न्यायालयाने दुरुस्ती स्थितीत देण्यापूर्वी खासगी शाळांनी या कोट्यातून दिलेले प्रवेश तसेच राहतील, असेही खंडपीठाने स्पष्ट केले. राज्य सरकारने शिक्षण हक्क कायद्यातील राखीव आणि वॉचिंग घटकातील

**मुंबई**: विधानसभा निवडणूकीचे पडसम वाजू लागले आहेत. पुढील दोन ते तीन महिन्यांत विधानसभा निवडणूका होणार असून या पाववेभूमिवर निवडणूक आयोगाने राष्ट्रवादीचे पक्षचिन्ह असलेल्या 'तुतारी वाजवणारा मासुल'शी साधर्म्य अस्पर्शी 'पिपाणी' व 'तुतारी' ही मुक्त चिन्हे गोठवण्याचा निर्णय घेतल्याने राष्ट्रवादी शरद पवार गटाला मोठा दिलासा मिळाला आहे. निवडणूक आयोगाने अश्व उमेदवारांच्या निवडणूक चिन्हांकना वदतीलेल 'पिपाणी' व 'तुतारी' हे चिन्ह गोठवण्याचा निर्णय घेतला आहे. लोकसभा निवडणूकीत शरद पवार यांच्या राष्ट्रवादीने १० जागा लढवल्या होत्या. नाशिकसह सर्वच जागांवर ४ लाखोतून अधिक मतदान 'पिपाणी'ला पडले होते.

A global technology outage grounded flights, knocked banks and hospital systems offline and media outlets off air on Friday in a massive disruption that affected companies and services around the world and highlighted dependence on software from a handful of providers.

Cyber security firm CrowdStrike said that the issue behind the outage was not a security incident or cyber attack - and that a fix was on the way. The company said the problem occurred when it deployed a faulty update to computers running Microsoft Windows.

But hours after the problem was first detected, the disarray continued - and escalated. Long lines formed at airports in the US, Europe and Asia as airlines lost access to check-in and booking servers at a time when many travellers

are heading on summer vacations. News outlets in Australia -- where telecommunications were severely affected -- were pushed off air for hours. Hospitals and doctor's offices had problems with their appointment systems, while banks in South Africa and New Zealand reported outages in their payment system or websites and apps.

At Hong Kong's airport, Yoonme Lee 24 said she found her flight to Phuket in Thailand was postponed to Saturday only when she arrived at the airport. Her already short five-day trip would now have to be further shortened, she said. Some athletes and spectators descending on Paris ahead of the Olympics were delayed as was the arrival of their uniforms and accreditations, but Games organisers said disruptions were limited and didn't affect ticketing or the torch relay.

### Flight cancellations in metros

## AIRLINES ARE LOGGED OUT

The worldwide Microsoft outage disrupted airline operations in India as well, resulting in flight cancellations and long queues of passengers outside airports and at check-in counters. The flight cancellations were at Mumbai, Delhi, Bangalore, Chennai and Hyderabad airports. Indigo, Vistara, Akasa, SpiceJet and Air India flights were affected, with over 200 flight cancellations, 192 by Indigo alone.

Services like booking, check-in and boarding procedures, including the issuance of boarding passes, were being carried out manually, which took longer than expected, leading to long queues at airports. Indigo, AI Express, Air Asia, SpiceJet and Akasa were impacted and not able to access their airline check-in systems. "Boarding passes are being issued manually. But Mumbai Airport systems are not impacted," said Mumbai Airport spokesperson

### Market, banks: Minor hiccups

The crashing of applications of the Microsoft operating system knocked out worldwide banks, stock exchanges, payment systems and emergency services. Top trading and brokerage houses, including NuVama and Edelweiss, were among those impacted. However, Indian stock exchanges were not disrupted by the outage, with the NSE and BSE denying that trading was impacted. Indian banking and financial institutions, too, faced minor disruptions. The Reserve Bank of India (RBI) made an assessment of the impact of the outage on its Regulated Entities and asserted the Indian financial sector in its domain remains insulated from the global outage.

The state election commission has frozen the trumpet and 'turha' symbols, in what is considered a big relief for the NCP Sharad Chandra Pawar group. The party had made a request to the EC, seeking to restrain the use of these symbols, claiming that their party had lost several seats in the recent Lok Sabha elections because of these. Independent candidates cannot use these symbols in future elections.



The secretary of the state election commission, Suresh Kakani, passed an order in this regard. After the recent Lok Sabha elections, NCP SP leaders had claimed that the voters of Maharashtra had become confused by the pol symbols of the NCP SP and an Independent candidate, which looked similar. The

party also said that similar symbols had reduced their margins in multiple seats in the general elections.

The Election Commission had allocated the 'man blowing turha', symbol to the Sharad Pawar faction, after the party split in July last year. Later, an election symbol named the 'pipam' (trumpet) was allocated to Independent candidates, which resembled the NCP SP election symbol. The party had claimed that they lost the Satara Lok Sabha seat due to this similarity in symbols, which had resulted in voter confusion.

US REPORTER JAILED IN RUSSIAN SPYING CASE

A RUSSIAN COURT found US reporter Evan Gershkovich guilty of espionage on Friday and sentenced him to 16 years in a maximum security penal colony in what his employer, the Wall Street Journal, called "a disgraceful sham conviction." Gershkovich, a 52-year-old American who denied any wrongdoing, was the first US journalist accused of spying in Russia since the Cold War.

ROAD TO WHITE HOUSE

Trump basks in GOP control as Biden campaign hits low

WITH A SPEECH at the Republican National Convention that recounted details of an assassination attempt, Donald Trump basked in a moment that showed his grip on the party to be tighter than ever — and veered into territory Democrats hope is Achilles heel.

Trump's address in Milwaukee on Thursday was the finale of a raucous convention that borrowed heavily from his roots as a TV showman and where emboldened Republicans reveled in the party's soaring fortunes. The GOP nominee began the remarks with calls for unity, though he later swerved into the dark immigration rhetoric, America-first messages and off-the-cuff riffs that were hallmarks of his polarising first term in the White House. His recounting of the shooting days before — a "loud whizzing sound," blood "going everywhere" — was met with the pindrop-silence of a rapt crowd.

The triumphant set piece for Trump made for stark contrast with his rival, President Joe Biden, whose campaign is at its lowest moment as the candidate isolates at home due to Covid-19 while a rebellion simmers in his party that could force him off the ticket. Before

Trump's speech, Montana Senator Jon Tester joined calls for Biden to bow out, the second senator to do so.

Trump's appearance was galvanising for a party that was shaken after Saturday's shooting in Pennsylvania that left one rallygoer dead, two others seriously hurt, and the nominee himself with a wounded ear. "I'm not supposed to be here tonight," Trump said, drawing chants of "yes you are" from the crowd. "I stand before you in this arena only by the grace of almighty God."

Trump asks China to make cars in US in departure from Biden

FORMER PRESIDENT DONALD Trump has reiterated an openness for Chinese automakers to build cars in the US as a way to boost the economy, signaling a potentially different approach from a Biden administration that has sought to keep out vehicles with links to the country. "Right now as we speak, large factories just are being built across the border in Mexico" by China to make cars to sell in the US, Trump said at the Republican National Convention. "Those plants are going to be built in the United States and our people are going to make those plants," he said.

Israeli occupation in Palestine is illegal: ICJ

THE UNITED NATIONS' highest court said that Israeli settlements in occupied Palestinian territories are illegal and all states should cooperate to bring an end to the Israel-

Palestinian conflict, in an important advisory opinion issued on Friday.

The findings by judges at the International Court of Justice (ICJ), known as the World

Court, are not binding but carry weight under international law and may weaken support for Israel.

"Israeli settlements in the West Bank and East Jerusalem, and the regime associated with them, have been established and are being maintained in violation of international law," President Nawaf Salam said.

Quota protests spread in Bangladesh, telecoms hit

THREE PEOPLE WERE killed in Bangladesh on Friday as police cracked down on unrelenting student-led protests against government job quotas despite a ban on public gatherings, local media said.

Police fired tear gas to scatter protesters in some areas, Reuters journalists said. One said he could see many fires across the capital Dhaka from a rooftop and smoke rising into the sky in several places.

Telecommunications were also disrupted and television news channels went off the air. Authorities had cut some mobile telephone services the previous day to try quell the unrest. Bengali newspaper Prothom Alo reported train services had been suspended nationwide as protesters blocked roads and threw bricks at security officials.

Three people were killed on Friday, it said, after violence on Thursday in 47 of Bangladesh's 64 districts killed 27 and injured 1,500. Reuters could not immediately verify the reports and police have not issued a casualty toll.

The protests initially broke out over student anger against controversial quotas which set aside 30% of government jobs for the families of those who

AmEx lifts 2024 profit forecast

CREDIT CARD GIANT American Express raised its full-year profit forecast on Friday, as its wealthy customers persisted in splurging on travel, dining and entertainment. The company also reported better-than-expected second-quarter profit, underscoring the benefit it has enjoyed by focusing on premium customer base. AmEx's affluent cardholders

have somewhat insulated it from weakness in the broader economy, even as rival lenders warn of tepid demand due to elevated borrowing costs. "Increased scale, combined with our premium, high credit quality customers, our well-controlled expense base and our successful investments... fuels the earnings power of the core business," CEO Stephen Squeri said. The company sees its 2024 earnings per share between \$13.30 and \$13.80, versus the \$12.65 to \$13.15 range it had forecast earlier in the second quarter ended June 30. Profit was \$3.02 billion, or \$4.15 per share, 39% higher than a year ago. Revenue jumped 9% to a record \$16.3 billion, but fell short of an S&P estimate of \$16.59 billion. —REUTERS

# L Catterton to Raise ₹4k-cr India Fund with Eye on Consumer Play

Mumbai: In what could be the first instance of a global private equity fund launching an India investment vehicle, consumer-focused PE firm L Catterton is in the process of raising a rupee fund, people in the know said.

The firm, backed by French luxury fashion house LVMH, plans to raise ₹4,000 crore under the guidelines for Category-II alternative investment funds. L Catterton manages around \$10 billion of equity capital. It has applied to the market regulator to register the India-focused vehicle. It announced in March 2024 as a Category-II AIF,

the people said. The entity, a joint venture with former Hindustan Unilever chief executive Sanjay Mehta, will invest in India alongside its next Pan Asia dollar fund on a pro rata basis, they said.

L Catterton will tap investors such as banks, insurance companies, pension funds, family offices and high net worth individuals for deploying in India across seven to nine deals, the people said. The entity will be managed by Mehta, who is its executive chairman for India, and partner and head of India at L Catterton Anjana Sasidharan. The rest of the L Catterton Asia leadership team hel-

The fund, with a focus on consumer sector, will consider both majority and minority investments.

When contacted, L Catterton declined to comment. During his tenure at HUL, Mehta oversaw market-leading products and services which were consumed by over 90% of Indian households. Around 20 of the brands he oversaw each achieved a turnover of ₹1,000 crore per year, as he helped build the company's network in India to span more than 1,000 suppliers and around nine million retailers.

- The above results have been reviewed by the Audit Committee and approved by the Board of Directors at its meetings held on 19/07/2024.
- The Scheme of Amalgamation of UltraTech Nathdwara Cement Limited (UNCL) (a wholly-owned subsidiary of the Company) and its wholly-owned subsidiaries viz. Swiss Merchandise Infrastructure Limited (SWISS) and Ment Plaza Limited (Ment) with the Company is effective from 20/04/2024. The Appointed Date for the amalgamation is 01/04/2023. Since the amalgamated entities are under common control, the accounting of the said amalgamation in the standalone financials has been done applying Pooling of Interest method as prescribed in Appendix C of Ind AS 103 'Business Combinations'. While applying Pooling of Interest method, the Company has recorded all assets, liabilities and reserves attributable to the wholly owned subsidiaries at their carrying values as appearing in the consolidated financial statements of the Company. The aforesaid scheme has no impact on the Consolidated Financial Results of the Group since the scheme of amalgamation was within the parent company and wholly owned subsidiaries. Tax expenses for the current period are considered after giving impact of the above merger.
- UltraTech Cement Middle East Investments Limited (UMCEL), a wholly-owned subsidiary of the Company, has completed the acquisition of 125,030,250 shares representing 25.00% of the share capital of Raj Al Khaima Co. for White Cement & Construction Materials P.S.C. (RAKWC) on 10/07/2024 under the partial conditional cash offer announced by UMCEL on 27/05/2024 which has been concluded on 24/06/2024. Together with the existing shareholding in RAKWC, UMCEL's aggregate shareholding in RAKWC stands increased to 54.39%. Consequently, RAKWC has become a subsidiary of UMCEL with effect from 10/07/2024.
- The Composite Scheme of Arrangement between Kesaram Industries Limited, the Company and their respective shareholders and creditors, in compliance with sections 230 to 232 and other applicable provisions of the Companies Act, 2013 (Scheme), has received the approval of the Competition Commission of India, the stock exchanges and the Securities and Exchange Board of India. The Scheme is now subject to the approval of the Company's shareholders, the National Company Law Tribunal and other statutory and regulatory approvals.
- In terms of a Scheme of Arrangement between Japrkash Associates Limited (JAL), Jaypee Cement Corporation Limited (JCC), the Company (the Parties) and their respective shareholders and creditors, sanctioned by the National Company Law Tribunal, Mumbai and Allahabad bench, together with necessary approvals from the stock exchanges, Securities and Exchange Board of India (SEBI), and the Competition Commission of India, the Company had on 27/06/2017, issued Series A Redeemable Preference Shares of ₹1,000 crores to JAL (Series A RPS) for a period of 5 years or such longer period as may be agreed by the Parties (the Terms). The Series A RPS were held in escrow until satisfaction of certain conditions precedent in relation to the Dalla Super Plant and mines situated in the state of Uttar Pradesh (Earlier known as JP Super), to be redeemed post the expiry of the Term as per the agreement between the Parties. Upon expiry of the Term, the Company offered redemption of the Series A RPS within the stipulated number of days, post adjustment of certain costs, performance as per the terms of the agreement entered into between the Parties. Redemption of the Series A RPS was subject to issuance of a joint notice to the escrow agent. The Series A RPS could not be redeemed due to inaction on the part of JAL in signing the joint instruction notice. This matter has since been referred to arbitration and the proceedings are pending.
- The Company (including erstwhile UltraTech Nathdwara Cement Limited) had filed appeals against the orders of the Competition Commission of India (CCI) dated 31/08/2016 (Penalty of ₹ 1,16,18,83 Crores) and 19/01/2017 (Penalty of ₹ 68,30 Crores). Upon the National Company Law Appellate Tribunal (NCLAT) disallowing its appeals against the CCI order dated 31/08/2016, the Company filed appeals before the Hon'ble Supreme Court which has, by its order dated 5/10/2018, granted a stay against the NCLAT order. Consequently, the Company has deposited an amount of ₹ 1,61,68 Crores equivalent to 10% of the penalty of ₹ 1,16,18,83 Crores. The Company, backed by legal opinions, believes that it has a good case in the matters and accordingly no provision has been recognised in the results.
