The Board of Directors in their meeting held on June 27, 2024, upon the recommendation of the Nomination and Remuneration Committee and Audit Committee considered and approved the appointment of Shri Saleem Ahmad, (Whole-time Director, NBCC) as Chief Financial Officer (CFO) and Key Managerial Personnel of the Company effective from July 1, 2024 till the regular incumbent assumes the Charge of Director (Finance).

A separate intimation would also be submitted w.r.t appointment of CFO.
