('the Company') and the promoters do not have any interest in this transaction. The transaction has been done at arm's length.
c)	Brief details of such guarantee or indemnity or becoming a surety viz. brief details of agreement entered (if any) including significant terms and conditions, including amount of guarantee	In consideration of ICICI Bank Ltd. agreeing to lend and advance term loans facility aggregating to Rs.138 crores ('TLs') to SSEL, which shall be availed by SSEL in one or more tranches, the Company has issued Letters of Comfort dated 30.9.2024 in favour of ICICI Bank inter-alia to ensure that SSEL abides by and complies with all the terms and conditions applicable to TLs including timely payment of interest & instalments, and the Company shall maintain controlling interest in SSEL during the tenor of the TLs. It may be noted that on cumulative basis, the Company has so far issued Letters of
		Comfort in favour of ICICI Bank on behalf of SSEL to the extent of Rs.178 crores (includes Rs.40 crore issued earlier).
d)	Impact of such guarantees or indemnity or surety on listed entity.	In the event of default by SSEL, the Company shall be liable to indemnify the ICICI Bank and make payment of the outstanding dues under the transaction.
