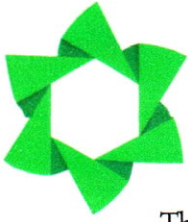

Ordinary Business

1. Adoption of the Standalone and Consolidated Annual Audited Financial Statements for the year ended 31st March, 2024 including the Balance Sheet as at 31st March, 2024 and Statement of Profit and Loss for the year ended on that date and the Reports of Board of Directors and Auditors thereon.
2. Declaration of Dividend on Equity Shares of the Company for the financial year ended March 31, 2024.
3. Re-appointment of Ms. Sheetal Bangur (DIN: 00003541), as a Director of the Company liable to retire by rotation.
4. Appointment of M/s V. Singhi & Associates, Chartered Accountants, (Firm Regn. No. 311017E), as the Statutory Auditors of the Company.

Special Business

5. Approval of Material Related Party Transactions.
6. Approval of Payment of Remuneration by way of commission to Non-Executive Directors

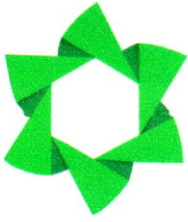
