This is to inform you that Annual Secretarial Compliance Report under Regulation 24A of the SEBI (Listing Obligations and Disclosure Requirements) (Amendment) Regulations, 2018 read with BSE Circular No. LIST/COMP/10/2019-20 dated May 09, 2019 is not applicable to our Company.

Further, we would like to inform you that our Company is claiming exemption under Regulation 15(2) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 as provisions of Corporate Governance as per Regulation 15 (2) (b) of SEBI (Listing Obligation and Disclosure Requirements) Regulations, 2015 the compliance with the provisions as specified in Regulation 17, 17A, 18, 19, 20, 21, 22, 23, 24, 24A, 25, 26, 27 and clause (b) to (i) and (t) of sub-regulation (2) of Regulation 46 and Para C, D and E of Schedule V shall not apply to listed entities having Paid up Equity Share Capital not exceeding Rs. 10,00,00,000/- (Rupees Ten Crores) and Net worth not exceeding Rs.25,00,00,000/- (Rupees Twenty five Crores), as on the last day of previous financial year.

During the previous financial year, the paid-up share capital of the Company is less than Rs. 10 crores, i.e., Rs. 348.72 Lakhs and net worth is not exceeding Rs. 25 Crore i.e. Rs. 324.23 Lakhs as on March 31, 2024 and therefore pursuant to Regulation 15(2) the requirement of Annual Secretarial Compliance Report does not arise. The Company has also submitted reply on the Listing Centre on "Communication Module".

Also, the Equity Shares of the Company got listed on the BSE w.e.f. 27 June, 2023. Hence, we have considered the applicability of Regulation as per the previous financial year i.e. 2023-2024.
