## Sub: Outcome of Board Meeting held on January 03, 2025

The Board of the Company, at its meeting held today i.e. January 03, 2025, has allotted 12,200 equity shares of face value of Rs. 10/- each to the eligible Employees of the Company who have exercised their stock options under the Dynacons-Employees Stock Option Plan 2020 ("ESOP-2020"). These shares shall rank pari passu with the existing equity shares of the Company in all respects. In this allotment, the Company did not allot any shares to Directors of the Company.
