Dear Sirs,

With reference to the captioned subject, I would like to state as follows -

- 1. At present, I hold 53812 Equity Shares in the Company which constitutes 0.34% of the paid-up capital of the Company. Persons related to me in 'Promoter & Promoter Group' hold 0.86% of the paid up capital which together with my holding constitutes 1.21% of the paid-up capital of the Company. I understand that I have been classified as Promoter of your Limited and reported under the category of 'Promoter & Promoter Group' in the Shareholding Pattern filed with the Stock Exchange where the securities of the Company are listed.

  - d. are not member(s) of the Board of Directors (including not having a nominee director) of the company.
  - e. do not act as a Key Managerial Person of the Company.
  - f. arenot 'willful defaulter(s)' as per Reserve Bank of India Guidelines.
  - g. arenotfugitive economic offender(s).
- 3. I hereby submit that I hold very less number of shares in the Company, I am not related to the key promoters of the Company, I am not involved in the operations of the Company in any manner whatsoever and neither exercise any control over the Company, directly or indirectly nor do I have any influence over the Board of Directors or hold any key managerial position in the Company or involved in day to day matters of the Company.

In view of the foregoing, I request that my shareholding be reclassified from the 'Promoter & Promoter Group' category to 'Public' Category of shareholders of the Company.

Ifurther confirm and undertake that I shall continue to comply with the conditions mentioned under Regulation 31A(4) of SEBI (Listing Obligation and Disclosure Requirements) Regulations, 2015 post re-classification of my name from 'Promoter& Promoter Group' of the Company to the Public category.
