



This application has been filed calling upon the respondents /Judgment Debtors to forthwith state on affidavit the particulars of the assets held by the respondent /Judgment Debtor, including movable and immovable, as provided in Order XXI Rule 41(2) of the Code of Civil Procedure, 1908 and in event of failure of the respondent/Judgment Debtor to produce detailed particulars of their assets, including fixed, tangible, intangible, movables and immovables as set out in the financial statements and otherwise provided in Order XXI Rule 41(2).

2. From the earlier proceedings, it could be seen that affidavit had been filed by the Judgment Debtors disclosing the assets. However, the learned Senior Counsel appearing for the applicant would indicate that there has been discrepancies in the affidavit of assets have been shown before this Court. Even though the said assets have not available with them giving the details to this Court, the learned counsel appearing on behalf of the Judgment Debtor would contend that the affidavit had only disclosed the assets that was available as on an earlier date that the date of filing such affidavit.

disclose on affidavit in the prescribed format within a period of two weeks

i.e., on or before 04.10.2024.
