Ref: Your email dated 12th June, 2024 for submission of reason(s) for delay in submission of the Audited Financial Results for the Half Year and Year ended 31st March, 2024

Pursuant to the provisions of Regulation 33 of the Listing Regulations, the Company was required to submit to BSE Limited ("the stock exchange") its Audited Financial Results for the Half Year and Year ended 31st March, 2024 within 60 days from the end of the financial year i.e. by 30th May, 2024 and the Company submitted the Audited Financial Results for the Half Year and Year ended 31st March, 2024 on 31st May, 2024.

In terms of Chapter III of SEBI Master Circular No. SEBI/HO/CFD/ PoD2/CIR/P/2023/120 dated July 11, 2023 (erstwhile SEBI Circular No. CIR/CFD/CMD-1/142/2018 dated November 19, 2018 we hereby disclose that due to the following reasons there was delay in submission of Audited Financial results of the Company for the Half year and Year ended 31st March, 2024:

- 1. As per the intimations dated 22^{nd} May, 2024 submitted to stock exchange vide acknowledgement numbers 7310308 and 2205202410483033 (XBRL), the Company conducted its Audit committee meeting on 30^{th} May, 2024.
- 2. In the meeting held on 30^{th} May, 2024, the members of the Audit Committee were not able to complete the review and finalisation of the audited financial results as placed before them.
- Consequent to the above, the members of Audit committee and the Board of Directors decided to adjourn the Audit committee and Board of Directors meetings on the next day i.e. 31st May, 2024 which was intimated to the stock exchange vide our intimation letter dated 30th May, 2024 filed through acknowledgement number 7370636.
