Sub.: Disclosure under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 – Update on ongoing litigation

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with SEBI Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023 and our disclosure dated August 14, 2023 on continuing events or information, we wish to inform you that the Chief Controller Revenue Authority, Maharashtra State, Pune vide order dated September 30, 2024 (**‘the said Order’**) has partially allowed the appeal filed by the Company against the order dated October 3, 2022 passed by the Collector of Stamps, Enforcement-I, Mumbai (**‘impugned Order’**) in the matter of adjudication of stamp duty payable on the order and judgement dated January 22, 2010 passed by the Hon’ble Bombay High Court and order dated February 4, 2010 passed by the Hon’ble Andhra Pradesh High Court respectively, sanctioning the Scheme of Amalgamation of M/s. H&R Johnson (India) Limited and RMC Readymix (India) Pvt. Ltd. with the Company.

Pursuant to the said Order, the Chief Controller Revenue Authority, Maharashtra State, Pune has directed the Collector of Stamps, Enforcement-I, Mumbai to process and grant revenue refund of excess stamp duty of ₹ 11,08,68,169/- (Rupees Eleven Crores Eight Lakhs Sixty Eight Thousand One Hundred Sixty Nine) and excess penalty of ₹ 1,72,88,870/- (Rupees One Crore Seventy Two Lakhs Eighty Eight Thousand Eight Hundred Seventy) to the Company within 15 days of the receipt of the Order. The Company had paid stamp duty of ₹ 17,72,79,661/- (Rupees Seventeen Crores Seventy Two Lakhs Seventy Nine Thousand Six Hundred Sixty One) and penalty of ₹ 2,12,73,560/- (Two Crores Twelve Lakhs Seventy Three Thousand Five Hundred Sixty) in October 2022 under protests pursuant to the impugned order.

The Company has received the copy of the said Order on October 5, 2024.

You are requested to kindly take the same on record.
