A Christmas tree was reportedly burned by a group of hoodie-donning men in a Christian-majority Syrian town, near the city of Hama, causing widespread protests.

Representatives of the Hayat Tahrir al-Sham (HTS), the rebel group that replaced the fallen Bashar al-Assad regime in Syria, were quick to respond, saying that the tree would be replaced ahead of December 25.

'US committed to stable, democratic Bangladesh'

United States National Security Advisor Jake Sullivan on Monday held discussions with Chief of Staff to President Joe Biden, reaffirming the United States' commitment to supporting a "prosperous, stable, and democratic" Bangladesh.

Earlier on December 12, National Security Communications Advisor John Kirby in a White House press briefing had said that the country as well as President Joe Biden were closely following the events in Bangladesh. "The security situation in Bangladesh has been difficult following the ouster of the former prime minister, and we've been working closely with the interim government to enhance the capability of their law enforcement and security services to deal with the challenge," Kirby had said.

During a telephone conversation, both leaders emphasised the importance of protecting human rights for all individuals and discussed ways to address the challenges Bangladesh is facing, the White House said in a statement.

It added, "Both leaders expressed their commitment to respecting and protecting the human rights of all people, regardless of religion. Sullivan reiterated the United States' support in meeting the challenges Bangladesh faces."
