Sub: Notice for non-compliance with SEBI (LODR) Regulations, 2015

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, this is to inform you that the National Stock Exchange of India Limited (NSE) and BSE Ltd.
