Brigade Group Signs Agreement to Develop a Third World Trade Center (WTC) Tower at Infopark Kochi

Bengaluru, June 19, 2024: Leading real estate developer, Brigade Group, announced it would develop a third tower of the World Trade Center (WTC) at Infopark Kochi.
