It hasn't been a month that a Shiv Sena leader's son, Mihir Shah (24), rammed his speeding BMW into a scooter allegedly under the influence of alcohol in Worli, resulting in the death of a 45-year-old Kaveri Nakhwa, who was riding back home with her husband after buying fish from the Sasson Dock Although the case brought strong consequences of police raiding bars and restaurants to check whether alcohol was being served to underage customers, a sting operation by The Free Press Journal proved that things have returned to lawlessness within a month.

were spotted sitting in the airconditioned section on the first floor. The reporter ordered a glass of whisky and was served a glass of whisky and was served a glass of whisky and as stilled. Moving alread, the Free Fress Journal visited Lalif Restaurant and Bar on Shahid Bhagat SinjiR Road near the General Post Office, where a group of young boys were seen walking out of the bar. A police whick was also seen patrolling the road but the cops did not enter the bars to check on the customers. The manager and cashier at the counter at Lalif restaurant also did not ask for any age proof and the reporter was served a glass of whisky. Lastly, the FPJ reporter visited Cannar Lunch Home and Bar. A few steps away from Lalif Bar. He was granted entry post midnight along with other customers. While the bar was jam-packed, the reporter was served a glass of whisky without being asked for any age proof. The shutter was downed, but it was business as usual inside.

The sting operation highlights the state of lawlessness in Mumbai as bars seem to have no worry about serving liquor to an underage customer. Even after a number of road a accidents comprising underage youth killing people under the influence have surfaced in recent times, the Mumbai Police seem to be waiting for a few more instances before they ensure strict implementation of the rules.

'Bishnoi had nothing to do with firing outside Galaxy'

'Debt-ridden' and 'jobless', shooter seeks bail, says he was inspired by the dreaded gangster's ideals

Vicky Gupta, the man who opened fire outside Bollywood actor Salman Khan's house, has claimed that gangster Lawrence Bishnoi had no role to play in the case.

Two motorcycle-borne men fired five rounds outside Khan's Galaxy Apartment in Bandra in the early hours of April 14. The attack is said to April I4. The attack is said to have been carried out by the Bishnoi gang. During the investigation, the man who opened fire was identified as Vickykumar Gupta. The police has so far arrested six people – Gupta. Sagarkumar Pal, Sonukumar Bishnoi, Anujkumar Thapan, Mohd Rafig Choudhary and Harnal Sinhe – in connection

Mohd Rafiq Choudhary and Harpal Singh - in connection with the firing. Thapan died by suicide, hence the case against him has been abated. Gupta has moved a bail plea before the special court claiming that "he was actually influenced by the character of Lawrence Bishnoi from the electronic, print and social media, and was magnetically attached to the principles followed by Lawrence Bishnoi as Mr Lawrence Bishnoi was an ardent follower of [freedom fighter] Bhagat Singh."

He claimed that Bishnoi has been dragged in the case

"He was working as a labour in Tamil Nadu, and owing to Covid-19 pandemic, he lost his job. Therefore, he was having no other alternatives, but to contact Pal," Gupta claimed adding that Pal promised him to get a job of a driver in Jalandhar, However, when he visted Jalandhar, Pal asked him to go to Mumbui.
"The Accused No 2 [Pal] informed the applicant that we have to visit Mumbal for one auspicious mission to accomplish the same, and as the applicant to feed his family was in dire need of money, and the applicant was having no other alternatives, but to visit the city of Mumbai," read the bail plea.
