POSTAL BALLOT NOTICE

Notice is hereby given that pursuant to the provisions of Section 108 and 110 of the Companies Act, 2013 ("the Act") read with Rules made thereunder, General Circular Nos. 16/2020 dated April 8, 2020 and 17/2020 dated April 13, 2020 read with other relevant circulars, including General Circular Nos. 10/2021 dated June 23, 2021, 20/2021 dated December 8, 2021, Circular No. 09/2023 dated September 25, 2023 and Circular No. 09/2023 dated September 19, 2024 issued by the Ministry of Corporate Affairs, (herein after collectively referred to as "MCA Circulars"), Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), Secretarial Standard on General Meetings ("SS-2") issued by the Institute of Company Secretaries of India and any other applicable law, rules and regulations (including any statutory modification(s) or re-enactment(s) thereof for the time being in force), is being sought for the Resolution set out in the Postal Ballot Notice dated September 25, 2024 ("Postal Ballot Notice"), by means of Postal Ballot, only by way of electronic means (remote e-voting) facility provided to the members to cast their votes through electronic platform by NSDL, in view of the MCA circulars, please note that the physical copies of the Notice along with Postal Ballot Forms and pre-paid business reply envelopes are not being sent to Members.

The notice has been sent electronically on Tuesday, October 15, 2024, to the Members whose e-mail addresses are registered with the Company/ Depository Participants/Registrar & Share Transfer Agents i.e. Link Intime India Private Limited (RTA), as on Friday, October 11, 2024 (Cut-off date). The Notice containing e-voting instructions is also available on the Company's website at www.rpglifesciences.com, BSE Limited at www.bseindia.com, National Stock Exchange of India Limited at www.nseindia.com and National Securities Depository Limited ("NSDL") at www.evoting.nsdl.com. Members who have not received the Notice may download the same from the above mentioned websites.

The voting rights of the Members/Beneficial owners (in case of shares held in demat account) shall be in proportion to their shares in the paid-up equity share capital of the Company as on the cut-off date Friday, October 11, 2024. Members holding shares either in physical or demat mode as on the cut-off date, October 11, 2024 only shall be entitled to vote through remote e-voting. A person who is not a member as on the cut-off date should treat this notice for information purpose only. The Members are further informed that:

- The Business set out in the Notice is to be transacted through e-voting by electronic means only.
- The remote e-voting begins at 09.00 a.m. (IST) on Wednesday, October 16, 2024.
- The remote e-voting ends at 05.00 p.m. (IST) on Thursday, November 14, 2024 (both days inclusive).
- The cut-off date for determining the eligibility to cast vote by electronic means is Friday, October 11, 2024.
- The members may note that (i) the remote e-voting module shall be disabled for voting and the voting by electronic means shall not be allowed after the date & time mentioned under point no. 3 above; and (ii) once the vote on a resolution is cast by a Member, the Member shall not be allowed to change it subsequently.
- The manner of remote e-voting for Members holding shares in physical mode or demat mode or who have not registered their e-mail addresses with the Company/RTA, is provided in the Notice and available on the Company's website at www.rpglifesciences.com.
- Members are requested to cast their votes through remote e-voting process not later than 05.00 p.m. (IST) on Thursday, November 14, 2024 failing which it will be strictly considered that no vote has been received from the concerned Member.

The results along with the scrutinizers report shall also be intimated to BSE Limited and National Stock Exchange of India Limited where the equity shares of the Company are listed and will also be displayed on the Company's website www.rpglifesciences.com as well as on the website of NSDL www.evoting.nsdl.com.
