The Statutory Auditors have carried out a limited review on the unaudited financial results and issued unmodified report thereon.
 3. The exceptional items for the year ended March 31, 2024 of ₹ 56.55 Cr in Standalone results pertain to provision made for impairment of investment in one of the subsidiaries mainly due to its settlement of litigations / claims and profit on account of buyback of shares by a subsidiary. The Exceptional items for the year ended March 31, 2024 is ₹ 32.53 Cr in Consolidated results pertain to loss on account of settlement of litigation, funding of shortfall on settlement with lenders of an associate and gain on redemption of Optionally Convertible Debentures.
 4. The Company has filed the scheme of amalgamation with National Company Law Tribunal, Hyderabad, to merge NCC infrastructure Holdings Limited, a wholly owned subsidiary of the Company, with itself.
 5. Revenue from operations for the quarter and half year ended September 30, 2023, includes ₹ 351.34 crs charged off pursuant to an arbitration award and ₹ 151.95 crs claim recognised on account of settlement with a customer.
