We are pleased to present the report on the Postal Ballot conducted by **KFin Technologies Limited** ("the Company") seeking consent of its Members for the Special Resolutions as contained in the Notice of Postal Ballot dated **06**th **June**, **2024** ("Postal Ballot Notice").

- In terms of provisions of Section 110 of the Companies Act, 2013 ("the Act") read with Companies (Management and Administration) Rules, 2014, we were appointed as the Scrutinizer by the Company on 24th May, 2024 to conduct the Postal Ballot as contained in the Postal Ballot Notice.
- 2.
