Pursuant to Regulation 30 read with Schedule III of SEBI (LODR) Regulations, 2015, we wish to inform you that the Company received a Demand Notice bearing No.F.No.20(8)/56/07/OC/2018/Div.III/NPPA dated January 30, 2025 through E-mail dated January 30, 2025 from National Pharmaceutical Pricing Authority (NPPA) under the provision of Drugs (Price Control) Order, 2013 (DPCO 2013) in respect of the Orthopaedic Implants [Non-Scheduled Medical Devices] registered as "Drugs" under the Drugs and Cosmetics Act, 1940 and Rules, 1945, for a sum of Rs.49,28,419/- [Overcharged Amount – Rs.19,87,300/- plus Interest @15 p.a. Rs.29,41,119/-] and the same will be suitably dealt with by the Company.

The requisite details as required under the Listing Regulations and SEBI Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023, are enclosed herewith as Annexure-I.

Details of the violation(s) / contravention(s) committed or alleged to be committed	The Company revised the MRP of its Orthopaedic Implants from Rs.90,000 [for a set of four components] to Rs.1,00,000/-, in September, 2014. The 10% increase would mean a revised MRP of Rs.99,000/- and for operational convenience, it was rounded off to Rs.1,00,000/-. The rounding off amount of Rs.1,000/- has been treated as overcharging under Para 20 of the DPCO, 2013 by NPPA.
