With reference to the captioned subject, we would like to inform you that the Company has received an order from the Office of the Assistant Commissioner, Fauji Complex, Sai Road, Baddi – 173205, Himachal Pradesh for the period April 2019 to March 2020 imposing demand of INR 2,96,44,106/- (Tax INR 1,58,00,048 /-, interest INR 1,22,64,053 /- and penalty of INR 15,80,005 /-) under Goods and Service Tax Act,2017.

Based on the merits of the matter, prevailing law and advice of the consultant, the Company is planning to file an appeal against this order before the Commissioner (Appeals) and reasonably expects favourable orders from the appellant authorities.
