ORDER

1. This is a Company Petition filed under Section 59(7) of the Insolvency and Bankruptcy Code, 2016 (hereinafter called "Code") by a Corporate Person, namely NESCO Hospitality Private Limited, the Insolvency Professional, namely, Mr. Ajay Kumar for dissolution of the Corporate Person through voluntary liquidation and accordingly it has proposed for voluntarily winding up under Section 59 of the Code, read with Rules and Regulations therein. The Corporate Person has completed the requisite formalities and complied with the procedure of liquidation. The present petition has been filed for the dissolution under Section 59(7) of the Code.

Relevant facts in brief are as under:

- The company was incorporated under the provisions of the Companies Act,
 1956 on 26.12.2014 having CIN U55204MH2014PTC260414. The registered office of the company is situated at Hall-01, Nesco Complex,
 Western Express Highway, Goregaon East, Mumbai 400063.
- 3. The main object of the Company is to carry on business of Kitchens, Food Courts, Food Kiosks, Mobile Food Kiosks, Mass Catering, Eating Houses, Restaurants, Cafeterias, Café's, Taverns, Beer Houses, Micro-Breweries, Refreshment Rooms, Permit Rooms, Tea and Coffee Houses, Cold Drink



Houses, Bars, Clubs, Night-Clubs, Discos, Pubs, Restaurants, Star-Category Hotels, Serviced Apartments, Business Hotels, Guest Houses, Licensed Victuallers; serve and/or sell wine, beer and spirit products; to arrange for and provide entertainment, amusement, sports, recreational and educational facilities; to invest in or enter into a contract or joint venture with any Person(s), Partnership Firms, Association of Persons(AOP), Bodies Corporate, LLP, Companies or to take over or to undertake the management of any hotels, serviced apartments, restaurants, shops, canteens, food courts, kitchens, food and beverage dispensing areas, cafeterias, canteens, lodges, resorts, gymnasium, clubs that are engaged in mentioned business activities.

- 4. The Petition is being filed under Section 59(7) of Insolvency & Bankruptcy Code, 2016 by a Corporate Person, namely, NESCO Hospitality Private Limited through its Liquidator for dissolution of the Corporate Person through Voluntary Liquidation on the ground that the business of the Company has become commercially unviable and from the past few years it is not profitable to continue business activities therefore it was thought prudent to wind up the affairs of the Company voluntarily under Section 59 of IBC, 2016 at its Board Meeting held on 17.12.2021. The Corporate Person through its liquidator has completed requisite formalities and procedures of liquidation in compliance of Section 59 of IBC, 2016.
- 5. The majority of Directors after having made full enquiry into the affairs of the Corporate Person formed an opinion that Corporate Person will be able to pay its debt in full from the proceeds of assets to be sold on the Voluntary



Liquidation and the Company is not being liquidated to defraud any person.

The said declaration of solvency is dated 24.12.2021.

- 6. On 17.01.2022, members of the Corporate Person passed a Special Resolution in the Extra Ordinary General Meeting to voluntary liquidate the Company and to appoint Mr. Ajay Kumar, the Petitioner herein as the Liquidator with a remuneration of Rs. 5,00,000/- for performing the job of liquidation of the Corporate Person pursuant to provisions of Section 59(3)(c) of IBC, 2016. The creditors, namely ND & Associates Practising Company Secretaries and Arvind & Company, Chartered Accountants with total claim of Rs. 2,11,220/- have also given their consent for the said voluntary liquidation.
- 7. The Liquidator made a public announcement for inviting the claims in Form

 A as per Regulation 14 of the IBBI (Voluntary Liquidation Process)

 Regulations 2017 in "The Free Press Journal (English)" and "Navshakti

 (Marathi)" on 19.01.2022.
- 8. The Liquidator notified the Registrar of Companies, Mumbai on 18.01.2022 vide Form MGT-14 about the passing of a Special Resolution for voluntary liquidation of the Corporate Person. Further, the Liquidator has duly intimated to the Income-tax Department about the initiation of voluntary liquidation of the Corporate Person on 09.02.2022. IBBI has also issued one clarification regarding requirement of seeking No Objection Certificate/No dues Certificate from Income Tax Department vide Circular dated



15.11.2021.

- 9. Further, the Liquidator submitted the preliminary report dated 18.02.2022 to the management detailing the progress of liquidation, capital structure and estimated value of assets and liabilities of the company.
- 10. On the basis of claims filed by stakeholders, the Liquidator prepared a list of Stakeholders and forwarded the said list to IBBI as per Regulation 30 of IBBI (Voluntary Liquidation Process) Regulations, 2017 on 09.03.2022.
- of Rs. 2,97,46,000/- and current tax assets comprising TDS receivable (refund) of Rs. 80,543/- from Income Tax Department as per the audited financial statements as on 17.01.2022 and the Petitioner has obtained a Certificate from the Chartered Accountant dated 27.03.2023 to this effect.
- 12. The Liquidator further submits that the liquidator opened a Bank account in the name of "NESCO Hospitality Private Limited in Voluntary Liquidation" with the Central Bank of India, Marine Lines Branch, Mumbai for realisation and payment to the creditors and members. Subsequently, the Liquidator of the Company closed liquidation account on 15.03.2023.
- 13. The Liquidator filed final report dated 12.04.2023 stating that liquidation process had been completed by annexing Audited Accounts of liquidation. Finally, the Liquidator filed this Petition along with final report and sent a copy of the final report to the Registrar of Companies on 05.05.2023 vide e-





form GNL-2 and IBBI on 05.05.2023 via e-mail [in Compliance of Section 59(7) of Code, read with Regulation 38(2) of IBBI Regulations. The Liquidator has also sent copy of Final Report to shareholders on 10.05.2023. The Shareholders have given their undertaking on 22.08.2022 to pay any statutory dues or any liability which may arise in future in proportion to their shareholding.

ORDER

- 14. On the Petition filed by the Liquidator under sub-section 7 of Section 59 of the Code for dissolution of this Corporate Person, we have noticed that the affairs of the Company have been completely wound up and its assets are liquidated. We are of the considered view that this Corporate Person, through its Liquidator, voluntarily liquidated itself so as to get dissolved. Therefore, we hereby dissolve this Corporate Person directing the Liquidator to file this order with the concerned Registrar of Companies and IBBI within 14 days thereof (Compliance of Section 59(7-9) of the Cede).
- 15. Accordingly, the present Company Petition No. 461(MB)/2023 is allowed.
