This is to inform that the Nomination and Remuneration Committee ('Committee') of the Board of Directors of the Company, by way of circular resolution on November 18, 2024, has approved the allotment of 26,200 (Twenty Six Thousand Two Hundred only) Equity Shares of Rs. 10/- (Rupees Ten only) each to the eligible employees of the Company upon exercise of the Options vested with them under the Repro India Limited - Employee Stock Option Scheme 2010.

Consequent to this allotment, the paid-up equity share capital of the Company stands increased from Rs. 14,29,72,880 (consisting of 1,42,97,288 equity shares of face value of Rs. 10 each) to 14,32,34,880/- (consisting of 1,43,23,488 equity shares of face value of Rs. 10 each).

The Company is in the process of applying for the listing application with BSE Limited and National Stock Exchange of India Limited for the aforementioned allotment.
